We begin each year with 100% of our expense budget to raise, but with your help we have done it time and again. Thank you for all you do!

“Our brother Timmy was high-energy, driven, and caring. He loved skiing, and boating, and his family. Even as he fought a nearly three-year battle with colon cancer he found a way to be active, at the same time making his illness about more than just himself. Most importantly, he gave his family and friends a way to remember and honor him—with the help of the Cancer Community Center.

“After Timmy was diagnosed with cancer, it was important for him to keep moving and stay healthy through exercise. He turned to cycling, which became a great tonic for him. But he also wanted to take his cancer journey to a another level, to find meaning in it and support others. He was that kind of guy—goal oriented, and always looking for a way to help.

“He heard about the Pan-Mass Challenge—a fundraising ride for the Dana- Farber Institute—and Timmy was in. He rallied some college friends and they formed Team Headstrong. The second year Tim did the Pan-Mass, he was in the hospital just a few days before the event. He did everything he could to get himself discharged, and he rode on the second day. Team Headstrong.

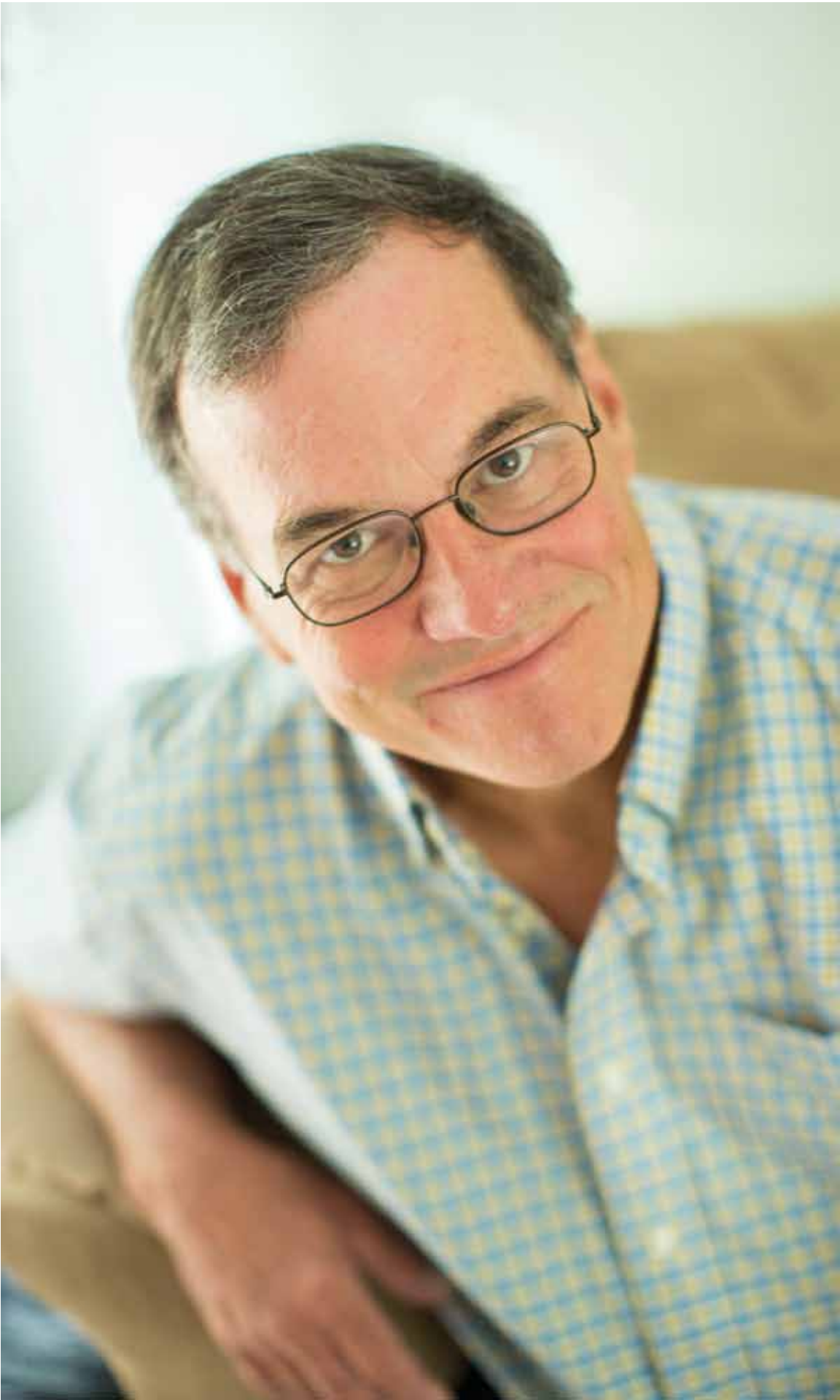
“When Timmy learned about the CCC’s Fight Back Festival, a light went off in his head: it was for a great cause, it was family-oriented, it was fun, and it was local. Team Headstrong rode in the event in 2011. The next day—while he was having chemo—Timmy was already jotting down ideas to make it better. He was always thinking!

“The CCC has provided tremendous support for our family. The people here understand that this journey doesn’t end with death. Grieving continues. Our family, and extended family, have embraced the Fight Back Festival as a way to fill the void that Timmy’s passing left in all our lives. He knew that it would.

He told us to focus on it, because it was fun. That was our brother, even when he was sick he wanted so much for other people to feel better.

“Team Headstrong raised more than \$19,000 for the CCC at the 2012 Fight Back Festival, with nearly 60 participants riding, running, and cheering. We’re out to smash that record at this year’s festival. Timmy was always trying to out-do himself. As a team, we’re keeping that tradition alive.”

“Live. Love. Laugh.” That was my sister Cathy’s motto. It’s on her gravestone. Cathy was a founding board member of the Cancer Community Center; ironically cancer got her ten years later. By then, she had helped build an extraordinary community.

“Cathy was always the glue in our family. Of six siblings, she was the one who organized family reunions, remembered birthdays, and was an amazing aunt to nieces and nephews. She had a heart of gold.

“When our sister Janice was diagnosed with breast cancer, Cathy was the one to go down to Virginia to be with her. Janice’s husband was deployed in the Navy, and the rest of us were up here in Maine. So Cathy cruised down to be there for Janice while she was going through that ordeal. That’s why she became involved with the fledgling CCC. She saw what it was like to be alone and have cancer, and she didn’t want anyone to have to go through that.

“Unfortunately, both Janice and Cathy had the BRCA gene that Angelina Jolie has recently brought to the public’s attention. Women with this gene have a much higher risk of breast cancer and/or ovarian cancer. Janice is a breast cancer survivor. But Cathy was diagnosed with ovarian cancer in 2005 and died three years later.

“I remember being with her toward the end, watching Sports Center and getting more and more depressed, while she was sleeping on the couch. Or so I thought. Suddenly she says, ‘Change the channel to TBS.’ So I started watching a Seinfeld re-run and pretty soon I was laughing, and she said, ‘The best thing for me now, is to hear you laugh.’ That was Cathy—always thinking of others.

“When she passed, my brother Bill and I made it our mission to support the CCC, because it was so important to Cathy. Bill joined as a trustee. I said I’d do anything—as long as I didn’t have to think too hard. And I’ve had a blast.

“Early on I remember being at the Center, stuffing envelopes, hearing these happy conversations, seeing all the people enjoying the classes and groups, and thinking ‘I get it. I get what Cathy saw in this place.’ The CCC is unbelievable.

“Now that I’m retired, they can’t get rid of me. I’m always asking what I can do to help. Last year at the Fight Back Festival, they had me picking recyclables out of the trash—and Channel 13 filmed it for posterity. Hey, anything for Cathy. Anything for the CCC.”

Nancy Pierce

"My sister, Carol Stark, died of multiple myeloma in 2006. She was diagnosed on the sixth of January and passed less than two months later. I miss her every day.

"Carol was a free spirit; a loving wife and step-grandmother; a strong hiker and skier. She had a challenging job with the Department of Defense, and was preparing for a transfer to Australia. She was 55-years-old when she died.

"Shortly after her diagnosis I was with Carol in Denver, when she turned to me and said, 'I wonder who I'm going to be now?' She was having some cognitive issues, due to the chemo, and I think that was the moment she realized that cancer would forever change her life. I could sense her anxiety and fear, and there was little I could do to help.

"It was then that I began searching for the Denver equivalent of a CCC. I knew Carol would find strength in such a community, and participating in classes would ease her anxiety. One of the ways that Carol had always de-stressed was through needlepoint. She was amazing; she could look at a picture and recreate it.

"I was dismayed to find no such program where Carol could go to find solace. I know my sister would have thrived at a CCC-style center, and she would have contributed. She might well have started a support group for others with multiple myeloma. The lack of such a place in a metropolitan area the size of Denver, seemed to me a stunning void.

"After Carol passed, my husband and I made a donation to the CCC. The following year I was asked to join the board. I always knew that the Center was doing wonderful things for those touched by cancer. But to experience it first-hand was to feel just how powerfully lives are changed here.

"The Center serves as part of a continuum that picks up where medical care leaves off. It saddens me to think of all the cancer patients without such a resource to help them navigate after their treatment ends. Cancer rocks your foundation, and the foundations of loved ones. It's like living on a perpetual earthquake. The CCC helps people rebuild, in much the same way communities come together after devastating natural disasters.

"Most poignantly for me, the Center helps people find answers to the question 'Who am I going to be now?' It provides a safe space to explore unsettled thoughts and feelings; to face and share hard truths, whether as a survivor, or as the loved one of a survivor or someone who has passed.

"I am so proud that a place like the Cancer Community Center exists here in Maine. It is very unique, and we are fortunate to have it in our state. Although you will never fully appreciate it until you need it, you don't have to have cancer, or know someone who does, to share pride in this place, and get to know more about the programs offered here."
